Details of incident(s)

I was coach on duty at the regional swimming competition on Sunday 1st March. In advance of the competition I had advised swimmers that I would select relay teams based on their swims in 50m and 100m events at the competition. This was also sent to parents/ carers by the club secretary with the officials' duty roster.

The team managers posted the relay teams daily in our team area which was in full view of all swimmers and supporters.

On Sunday morning Patrick Brennan (Team Manager) posted the 4 x 100m freestyle relay teams. Daniel Day (parent of Alysa Day) approached me in the spectator's area and asked why his daughter had not been selected for the team as she was faster than two of the swimmers listed (who he named). I informed Daniel of the selection criteria and that this was sent out in advance of the competition. Daniel stated that he didn't see this email and that it was ridiculous not to pick the best swimmers, just because they have one bad swim.

I felt there was a lot of people watching the conversation as the spectator's area was full and Daniel appeared to be quite annoyed. Alysa was standing close to her father and seemed to be embarrassed.

I attempted to end the conversation by telling Daniel that I needed to go down on deck to speak to some of the swimmers, but he blocked my path by putting his hands up at chest level. At this point I told Daniel that I felt uncomfortable by his behaviour and asked him to stand aside and let me leave. Daniel became irate and told me that I was a rubbish coach, I didn't know what I was doing and that I was deliberately preventing his daughter from reaching her potential.

John O'Neill and Aine O'Kane were sitting quite close to the conversation and at this point they both approached us. John asked Daniel to step back and let me past which he did. Aine walked with me to poolside.

Patrick (TM) came down on deck approximately 10 minutes later to tell me that Alysa had informed him that she had to leave and asked him if he could scratch her from her remaining events.

DESCRIPTION OF COMPLAINT

Daniel's behaviour towards me was aggressive and threatening in nature, by putting his hands up he was preventing me from leaving a situation that I did not feel safe in.

Daniel named two swimmers loud enough for other swimmers and parents to hear, alleging that they were not as good as his daughter. This exhibits unsportsmanlike behaviour, and these are disparaging comments to make about young people in our club.

Given that this was a regional competition and the area was full of spectators I also feel this behaviour reflects poorly on our club. Several coaches approached me that day to ask if I was okay, having heard about the incident from their own club members.
