Details of misconduct	Mark arrived in 10 minutes late for training session and proceeded to lane 3, where he normally swims. There were three other swimmers in lane 3 completing their warm-up when Mark arrived. Mark threw his kit bag down and kicked the three water bottles that were sitting at the edge of the lane, belonging to the swimmers in lane 3. The water bottles scattered across poolside. Mark made no effort to pick them up and was getting into the pool, so I called him over to speak to me.  I spoke to Mark in the presence of Siobhan McNamara (assistant squad coach) and within earshot of Anne-Marie Kennedy who was parent on duty (P.O.D) at all times.  I asked Mark to explain why he kicked the water bottles. He said he didn't mean to; it was just an accident. I told Mark it seemed to me that he arrived late and in a bad mood, that he kicked the water bottles on purpose, making no effort to pick them up. Mark became agitated and said, "For F*** sake, I'm never late, they are only stupid water bottles, I didn't hurt anyone, did I?"  At this point I felt Mark was becoming more worked up so I informed Mark that I was imposing a 5 minute time out and asked him to get his towel from his bag and to return and sit with Anne-Marie, with the 5 minutes starting from the time he sat down with the P.O.D.

him how he was feeling. Mark said he was fine and wanted to get into the pool to get on with his training.

I asked Mark if he had anything he wanted to say about what had happened before he was on time out. He got annoyed and said it was dumb that he had to sit at the side of the pool, he didn't really do anything wrong and that I was trying to hold him back from doing well in his swimming.

I told Mark that I was disappointed that he did not want to apologise to his teammates for his actions or to myself, Siobhan or Anne-Marie who witnessed and heard his use of bad language. Mark became angrier and threw his towel on the ground and continued to use bad language. I told Mark that his behaviour was completely unacceptable and that I was now expelling him from the session. I asked Mark to go and get dressed and return to poolside within 10 minutes to sit with P.O.D. I also asked the P.O.D. to call Mark's parent to collect him.

Mark's father arrived at 20.30 to collect Mark, I spoke with him briefly to inform him of what had happened and told him that I will be sending a more detailed report to the club secretary.
