INFORMATION ABOUT US

Our site is operated by The Irish Amateur Swimming Association Limited trading as Swim Ireland a company incorporated in Ireland with company number 112024 whose registered office is at Irish Sport HQ, National Sports Campus, Blanchardstown, Dublin 15 ("**We**" or "**Swim Ireland**").

ACCESSING OUR SITE

Access to our site is permitted on a temporary basis, and we reserve the right to withdraw or amend the service we provide on our site without notice.
